

# Target Market Determination

## For the Bendigo High Growth Wholesale Fund

### Product

This target market determination (TMD) applies to the Bendigo High Growth Wholesale Fund (BHGWf).

## 1. Target market for this product

### Target Market

The retail clients for whom this product has been designed are investors who:

- want long term capital growth from a portfolio of growth assets;
- want a high risk investment;
- want an investment with a time horizon of at least seven (7) years;
- can make an initial investment of at least the minimum investment amount (generally \$50,000);
- want the ability to make additional contributions to their investment (including through regular periodic contributions);
- want half yearly income distributions; and
- want access to a selection of investment managers that specialise in managing specific asset classes.

### Product Description



The BHGWf is a managed fund scheme for retail clients seeking a high risk investment, who are wanting long term capital growth from a portfolio of growth assets via a selection of investment managers that specialise in managing specific asset classes with at least a 7 year time horizon. This fund also allows investors to receive half-yearly income distributions.

### Product key attributes

Retail clients eligible for this product are Australian residents and retail clients who are non-residents residing in Australia.

### Instructions

### Appropriateness

### Investment products and diversification
