## Branch declares first dividend!

At its recent Annual General Meeting held on 19 November 2012, the Board of Directors took great pleasure in declaring the first dividend to be paid by the company at 5 cents in the dollar. The payment of the dividend reflects the substantial growth of the company's business in its relatively short history of just under four years, and has been made after the distribution of approximately \$125,000 in sponsorship grants to local community organizations in that same period. As the company is not yet making tax payments to the Australian Tax Office, the dividend payment was deemed unfranked.

A number of dividend cheques sent to shareholders in December still remain unpresented, whilst only a handful of EFT transactions were rejected due to incorrect bank details provided to Richmond Sinnott Delahunty, Chartered Accountants, who manage the share registry on our behalf. The most efficient and effective payment mode is clearly through EFT, and we would urge all shareholders to provide their bank account details to RSD at your earliest convenience.

Our total business is moving steadily towards \$90 million, which reflects in no small part the confidence shown in us by the local community. The Directors and staff of the **Community Bank**<sup>®</sup> branch take great pride in what has been achieved to date and, with the opportunity of establishing a **Community Bank**<sup>®</sup> branch in Riddells Creek presently being explored, we look forward to the success achieved in our first four years continuing and possibly expanding in the immediate future.

We have also provided ongoing support we have provided for many community groups and clubs over the last four years.



## New branch for Riddells Creek – Progress report

In 2012 an enthusiastic Steering Committee of prominent Riddells Creek residents came together to discuss the possibility of establishing a **Community Bank**<sup>®</sup> branch for their town. The group included two current Gisborne & District Community Enterprises Ltd Directors, Ian Barclay and Graham Stewart.

After several meetings with Bendigo Bank Managers and Gisborne & District Community Enterprises Ltd, the Steering Group requested that the proposed Riddells Creek **Community Bank**® Branch should be a second site of Gisborne & District (now Macedon Ranges) Community Enterprise Ltd franchise. Bendigo Bank were in favour of this suggestion and a set of guidelines were established with four key elements needed to be achieved in order for the project to become a reality.

#### Riddells Creek Community Bank®

Project was formally established in November 2012. It is chaired by Director Gary McSwain and the Secretary is Dale Furey. Other foundation members are David Hutchens, Richard Lee, Kristie Murden, Janine Radford, David Laurie, Andrew Nicoll, Jeff Shepherd and Don Clark. Ian Barclay and Graham Stewart are also foundation members.

There are a number of steps to be completed before opening the Riddells Creek **Community Bank**<sup>®</sup> Branch.

#### 1. Pledges of New Capital

The project needs to gather pledges for \$600,000 of new capital in Macedon Ranges Community Enterprises Ltd from a spread of Riddell residents/businesses. The new capital will cover establishment costs for the new branch and not adversely impact the balance sheet of the current business model.

#### 2. "Business on the Books"

Since the formal approval of Riddells Creek **Community Bank**<sup>®</sup> Project, all new business generated within the 3431 postcode is tagged to the "Riddell Project". Bendigo Bank has set a target of \$10 million of business within the Riddell community.

#### 3. Feasibility

Once the Riddell Project hits both of the above targets, Bendigo Bank will commission an independent review of both the pledged new capital and current/potential business within the Riddell catchment. If the findings are satisfactory, Bendigo Bank will inform Macedon Ranges Enterprise Ltd that a second franchise license can be issued for a **Community Bank**<sup>®</sup> branch in Riddells Creek.

#### 4. Prospectus

The Board of Directors of Macedon Ranges Community Enterprises Ltd will then determine when to launch a prospectus in order to raise the required new capital to fund the expansion into Riddells Creek.

Riddells Creek **Community Bank**<sup>®</sup> Project was launched at the Riddell CFA Expo in late November 2012. Since then the committee has held several card-table groups over Christmas and into 2013. We are delighted to report that pledges for capital already exceed
