Updating shareholder information

We are aware that many of our shareholders do not yet have their email or EFT Banking details registered with our Share Registry Department. Under the AFS Share Registry system, shareholders can now register online to change their own details when necessary, and/or update their information. If you have not yet registered to use the online system, please contact AFS Share Registry on email shareregistry@afsbendigo.com.au or call (03) 5443 0344 and they will help set you up to use the system.

Also, please note that all dividend payments will be made directly to a bank account via EFT – cheques will no longer be sent out in the mail. If you have not yet received your 2022 or 2023 dividend, please advise your banking details by registering online or by contacting the company secretary or branch staff to obtain a Shareholder Details form for completion and return as soon as possible.

If dividends are not collected, they are then passed onto the Victorian State Revenue Office Unclaimed Monies department, and you will have to apply to that department to receive your funds, so please complete the form to update your details as soon as possible.
