HOW TO COMPLETE YOUR PROXY FORM

1. Appointment of Proxy - General Information

Shareholders should note that:

- all shareholders have the right to appoint a proxy

2. Your name and address

This is your name and address as it appears on the company's share register. If this information is incorrect, please mark the box and make the correction on the form. Please note, you cannot change ownership of your shares using this form.

3. Appointment of a proxy

A shareholder entitled to attend and vote at the meeting may appoint one proxy to attend and vote on their behalf. A proxy need not be a shareholder of the company. A proxy may be an individual or a body corporate.
